Unfinished Business

- 1. **Fredonia Interconnections** Fredonia has hired an Engineering firm to review the interconnection plan. Mayor to set up meeting with our engineers but there is no new communication from Mayor Landis and Board of Trustees at this time.
- 2. Amendment to the Water Purchase/Supply Agreement with the City of Dunkirk no additional communication has been received from Mayor Rosas at this time. K. Tampio to contact City attorney Morrisroe for an update.

2. Capital Project Construction Update - Eric Wies

- Phase II Watermain design plans out to all agencies for review and responses
- Water Tank survey work continues
- Route 5 Sheridan main charged. Customers are progressing with hook-ups. Town of Sheridan District 3 process completed. Valve will not be opened up to supply new customers until change over from City of Dunkirk to NCCWD completed.

Discussion:

- NCIWD Water Tank discussion of pros and cons of rehabilitation of existing water storage tank at NCIWD instead of decommissioning or replacing new tank designed for location in Sheridan. Brian Purol explained that the last inspection of the NCIWD tank was in 2011 and at that time the estimate to rehab the tank was \$217,295. Current estimates placed rehab cost at approximately \$500,000. CPL engineer Wies explained that a check valve has been designed at the new Sheridan tank that will enable proper fire flow for NCIWD area. Wies will follow up with Randy Woodbury (City Dunkirk) to explain design of new tank and modelling to accommodate proper fire flow.
- Athenex fire flow Jay Warren expressed concerns for sufficient fire flow at new Athenex plant in Dunkirk. Current system is fed by 8" water main. When new 12" watermain comes on-line, it is expected that fire flow requirements will be met.
- **Pump Station** Discussion of pros and cons of rehabilitation of existing pump station versus construction of new pump station on Roberts Road. Eric Wies will work with Randy Woodbury to examine system hydraulics. A recommendation will follow at the next meeting.
- Meter Vaults two of five meter vaults have been installed but are not currently in operation. The Roberts Road meter vault is needed to turn over City of Dunkirk water billing for the NCIWD to NCCWD. NCIWD has changed its customer rates to reflect new water billing from NCCWD/CBI effective October 1, 2019 so will experience revenue deficit since the City water rate is higher than the NCCWD/CBI rate. Randy Woodbury will work with City to accomplish a target turn over by January 1, 2020.
- **CBI Water Loss issues** Dan Schrantz reported that work continues to determine causes for and ways to decrease municipal water systems water loss. Drew Smith is monitoring master meters and any possible recalibration needed. Rural Water has been contacted to assist with leak detection.
