- Brocton project complete except for minor restoration issues. One year warrantee ends 11/2019.
- Phase II improvements Middle Road Pump Station (owned by NCIWD) upgrade, new water main and Sheridan tank designs in process.
- Sheridan route 5 water main construction almost complete and service installation and disinfection of water mains in process.
- Meter Vaults contract with DJM in process at County Law Department and preconstruction meeting will be arranged.
- Discussion of replacement vs. maintaining NCIWD water storage tank.
- A check valve was installed to address the water loss issue of the west side water mains.
